(TEMPORARY PROHIBITION OF THROUGH TRAFFIC)

ORDER 2021/288

NOTICE is given that Cambridgeshire County Council has made an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the effect of which is to stop any vehicle from proceeding along Infield Road (B660), Glatton as lies between Sawtry Road and Glatton Footpath 3.

Access will be maintained to properties affected by this order.

The alternative route for vehicles is via B660 - B1043 - Alconbury Hill, Alconbury Weston - Vinegar Hill - North Road (C103) - Buckworth Road (C103) - Buckworth Road - Alconbury Weston Road, Buckworth - Hamerton Road (C106) - Buckden Road, Hamerton - Clopton Road - Buckworth Road, Old Weston - Hi.

The Order is made to facilitate tree maintenance works which are being carried out on or near this highway and it will come into operation on 8 April 2021 and continue until these works have finished or on the 7 October 2022 whichever is the earlier.

It is anticipated that these works will be carried out between 09:30hrs and 14:00hrs 8 April to 12 April 2021.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform.

Application for Temporary Road Closure at Infield Road (B660), Glatton

Your application for the above Order has been approved, and will come into operation on 8 April 2021.

All necessary legal procedures have been attended to by ourselves, the emergency services will be informed in due course and you will be invoiced accordingly.

Will you please note that the proper signing of the road obstruction must be in accordance with the Traffic Signs Manual Chapter 8 and must comply with the Safety at Roadworks and Street Works Code of Practice. Adequate signing of the alternative route is entirely your responsibility. You MUST place Advanced Warning Signs at each end of the highway to be closed at least 14 days prior to the closure informing the travelling public of the start and end dates of the closure.

All signing must be carried out to the entire satisfaction of the Local Highways Officer (Telephone Number 0345 045 5212) in whose area the work lies and you should make early arrangements to discuss the signing with them.
